#### **TERMS AND CONDITIONS:**

##### **\*USAGE RIGHTS:**

The fee of \$200.00 U.S. dollars is a one-time fee for each team. Each team will be photographed a minimum of one (1) game, 2 games photographed if your team plays in the championship game. There will be a minimum of 200 photos taken per game. Although we will do our best to get a photo of each player, due to injury or lack of playing time this may not be possible and the team fee incorporates that risk.

The digital photos are copyright released to reprint and enlarge to any individual for **personal use only**. Advertising, editorial, collateral, and retail product use is strictly prohibited unless otherwise negotiated. School newspapers may reproduce as many images as they wish but must agree to send 2 copies of the final printed material to Jeff Hinds with **name credit: "jeffhinds.com"** adjacent to or legibly printed over each image printed. Web site use is permitted and requires photographer notification, proper **name credit: "photo by: jeffhinds.com"** adjacent to each image along with a photo link to [www.jeffhinds.com](http://www.jeffhinds.com) on the main web site sports page. Upon notification of web site use, Jeff Hinds will provide the Sports Photography logo to use as the photo link. Failure to provide web site name credit will result in a \$500 fee per image and will be considered copyright infringement, subject to the maximum fines allowed by federal law (visit [www.copyright.gov](http://www.copyright.gov) for more info).

Each image taken will be registered with the US copyright office in Washington DC before being released.

Each team will have a designated "contact person". One (1) DVD will be delivered via US mail to this person within TWO (2) weeks following the tournament. It is the responsibility of that person to keep track of, and provide the original DVD to others for making copies. Additional, official DVD copies will be available for purchase through Jeff Hinds Sports Photography for \$50 each.

This form, along with the team fee must be filled out and mailed to Jeff Hinds Sports Photography (address above) before the tournament begins. With prior contact, the fee and form can be hand-delivered to Jeff Hinds at the tournament, before any games are photographed. A signed copy of this form will be returned to you upon delivery of images. Please fill out all sections listed below if applicable.
